

All health and social care services in the UK have Duty of Candour responsibilities. This is a legal requirement which means that when things go wrong and mistakes happen, the people affected understand what has happened, receive an apology and organisations learn how to improve for the future.

An important part of this duty is to provide an annual report about the duty of candour in our service. This short report describes how Springvale Care Home has operated the duty of candour during the period from1st April 2024 to the 31st of March 2025. We hope you find this report useful.

Springvale Care Home is satiated at the foot of the Campsie Hills in Lennoxtown, surrounded by beautiful views. We support up to 95 residents. We provide nursing, specialised illness and dementia care for older people who require care and support in a homely setting. We aim to ensure that our residents receive an excellent quality of care and live happy, fulfilled lives.

Within the last 12 months, there have been 6 incidents at the home, to which the duty of candour applied. These are where types of incidents have happened which are unintended or unexpected, and do not relate directly to the natural course of someone's illness or underlying condition.

## Duty of Candour Report 2024-2025 Springvale Care Home

When we realised the event(s) above had happened, we followed the correct procedure. This means we informed the people affected, apologised to them in person and in writing, and offered to meet with them and their family. We reviewed what happened and what if anything, went wrong to try and learn for the future.

If something has happened that triggers the duty of candour, our staff report this to the Home Manager who has responsibility for ensuring that the Duty of Candour procedure is followed. The Home Manager records the incident or accident and reports it as necessary to the Care Inspectorate/ Care Quality Commission, Springvale Care Home, the local contracting authority, the Regional Director, and the Quality Director, for the company. When an incident or accident has happened, the Home Manager and staff set up a learning review. This allows everyone involved to review what happened and identify changes for the future.

All new staff learn about the duty of candour at their induction. We know that serious mistakes can be distressing for staff as well as people who use care and their families.

6 Residents sustained fractures, 2 of which died as a result of the injuries. Staff have had appropriate training on escalation of care and post falls checks. Staff have had reflective practice training and have recognised what the home can do better to ensure the safety and wellbeing of those living in the service.

Duty of candour informs our learning and planning for improvements as a service, and as a company. It has helped us to remember that people who use our services have the right to know when things could be better, as well as when they go well.

As required, we have made this report available to the regulator but in the spirit of openness, we have published it to share with our residents and their relatives too.
